SUPERVISION STRUCTURE

NUMBERS

Due to the activity being adult supervised FP recommends no more than 50 bathers at a time with two supervising adults. This is a very conservative number based on the safety of the participant not on the instantaneous bath load number below.

Based on the instantaneous bathing load (standard 13.1.2.1) using the pool calculator provided by Stockwell Associates UK;

- Main pool
 - a. Max inst bath load: 124
 - b. Max operation daily bath load: 743
 - c. Design circulation flow rate (cubic meters per hour):211m²

RATIOS

Must have a minimum of two adults supervising at all times, wearing a red lanyard for easy identification.



SUPERVISION POSITION

Adult should be walking around the pool, whilst observing participants in the pool

RATIO SUPERVISION CHANGES

SPECIFIC SUPERVISION INSTRUCTIONS FOR ADULT HELPERS (WHEN ADULT HELPERS ARE UNDER SUPERSISION OF FP INSTRUCTOR)

Adults supervising the pool should constantly monitor all participants by actively scanning the pool for changes in behaviour, movement and position of participants. Adults should be walking around the pool and preferably not be sitting down. If the pool inflatable is present adults must be on either side of the inflatable to maximise visibility. Participants who are weak swimmers must be identified prior to the pool session.

ACTIVITY IN OPERATION

GENERAL EMERGENCY PROCEDURES AND RESCUE SCENARIOS

- a) Minor incidents (scale 1 5):
 - Pause the activity if needed
 - · Administer first aid (kit provided, or first aid room) Note: All groups are notified to bring their own first aid supplies.
 - Assess whether victim can continue or needs to return to camp
 - · Assess whether activity can continue
 - Fill out incident form and notify senior staff as soon as possible
- b) Serious harm incidents (scale 6 up)
 - Stop the activity
 - Ensure the safety of yourself and the participants.
 - Administer first aid
 - Contact senior staff immediately for extra assistance and/ or contact emergency services
 - With senior staff fill out incident report and investigation
- c) Flooding:
 - Move group to higher ground ASAP
 - Account for all staff and participants
 - Inform senior staff of situation
 - Return to camp or if not possible to nearest exit point
- d) High winds/ cyclone:
 - Move group to more sheltered position and/ or
 - Contact senior staff for rescue if unable to move
 - Account for all staff and participants
- e) Earth quake:
 - Move group to assembly area ASAP. (if within camp grounds set off fire alarm system)
 - Report to senior staff ASAP and account for all staff and participants.
- f) Fire:
- Move group away from imminent danger ASAP and find best possible safe one, raise the alarm and move toward assembly area ASAP.
- Report to senior staff ASAP and account for all staff and participants.
- Contact emergency services

A group has to have 2 adult supervisors wearing a lanyard each, so they are easily recognised as the supervisors. If one supervisor is to leave the area the pool has to be closed. The pool is fenced off by a solid fence with gates on either end, with child locks on them. When the obstacle course is present, the supervisors need to be on either side of the object as to cover all areas. Where necessary participants can be fitted with lifejackets if they are non-confident swimmers
